There will also be general questions about the rest of the course material. And as with the previous exams, there will be an off-line portion of the exam with calculations and a short essay question about an investment advertisement that a colleague of yours is interested in. There is a pre-final worksheet and answer key on the class web site with questions that look very much like the calculation questions on the off-line portion of the final (hint, hint, hint). Here is your last chance to learn how to calculate the present value of discounted cash flows!
